BY-LAW CHANGES to be voted on at the MAY QUARTERLY

Insert a new sentence 6.1.1.11 - Host Department to supply an A.E.D. device and have said device located at the main gate to the camp sites.

(3) SUB SECTION 1.2.4 GAMES AND COMPETITION COMMITTEE Add sentence 1.2.4.1(vii) Oversee the Fire Prevention Window Competition and award prizes to the winner(s).

Each member Department, Company, Association, or Auxiliary are required to seat two delegates. After attending 50% of the meetings plus the annual meeting said delegates will receive a life membership.
